

### STORAGE AND DISPOSAL

Rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. Dispose of at a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of w aterways, desirable vegetation and tree roots. # FLEA CONTROL

Thoroughly spray all infested area.

It is recommended that premises are vacuumed and contents of vacuum bag removed before treatment takes place. This is particularly important where adult fleas are present.

Ensure pets are treated with a suitable insecticide to avoid re-infestation of the treated premises.

Exterior Use: Prew etting the soil with a garden hose may be required on very dry soil.

# COCKROACH CONT ROL

When treating for cockroaches, apply thoroughly to cracks, crevices and other places where cockroaches may hide and breed. Apply to point of run off.

The low er (1 mL/L) rate will be effective in most situations for a full season. Use the higher rate under difficult conditions or where more than a season long control is required.

# SILVERFISH CONT ROL

When treating for silverfish apply thoroughly to surfaces in cupboards, cracks, crevices and other places frequented by silverfish. Apply to point of run-off.

# **GENERAL INSTRUCTIONS**

Triflumuron 480 is a slow acting insecticide which has its greatest effect on early juvenile stages of insects. Applied to breeding areas, Triflumuron will prevent pest populations from building up to problem levels.

Where quick action is required the use of a knockdown product as a tank mix with Triflumuron is recommended. Triflumuron is compatible with most adulticides such as Baytex and Responsar Beta SC. Alternatively, the concurrent use of bait or fogging treatments is recommended.

If used alone on established pest populations, it will take several weeks for populations to decline to acceptable levels (3-4 weeks for fleas and 1-2 months for cockroaches). Triflumuron should only be used alone when the pest population has already been reduced by other measures or when the property owner is willing to accept a slow action.

# GROUP 15A INSECTICIDE

For insecticide resistance management Triflumuron 480 Larvicide is a Group 15A insecticide.

Some naturally occurring insect biotypes resistant to Triflumuron 480 Larvicide and other Group 15A insecticides may exist through normal genetic variability in any insect population. The resistant individuals can eventually dominate the insect population if Triflumuron 480 Larvicide or other 15A insecticides are used repeatedly. The effectiveness of Triflumuron 480 Larvicide on resistant individuals could be significantly reduced. Since occurrence of resistant individuals is difficult to detect prior to use, A & C Rural Pty Ltd accepts no liability for any losses that may result from the failure of Triflumuron 480 Larvicide to control resistant insects.

# MIXING

Mix Triflumuron 480 in the required amount of water or prepared knockdown product to uniformly and accurately apply the required amount.

# PRECAUTIONS

Avoid contact with food, food utensils, or places where food is prepared or stored.

Before use – remove or cover all exposed foodstuffs; cover all dishes and utensils, and palces where food is prepared or stored.

After use - thoroughly ventilate treated area. Clean up thoroughly before processing/serving resumes.
