Section 4 - First Aid Measures

Inhalation

If inhaled, remove affected person from contaminated area. Apply artificial respiration if not breathing. Seek medical attention.

Ingestion

Section 6 - Accidental Release Measures

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. If possible contain the spill. Place inert absorbent material onto spillage. Section 7 - Handling and Storage

Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Do not use near ignition sources. Do not pressurise, cut, heat or weld containers as they may contain hazardous residues. Maintain high standards of personal hygiene by washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area away from sources of ignition, foodstuffs, clothing and incompatible materials such as oxidising agents. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Ingestion

May be fatal if swallowed and enters airways. Small amounts of liquid aspirated into the respiratory system during ingestion or from vomiting may cause severe pulmonary injury that may lead to death. May cause irritation to the mouth, throat, esophagus and stomach with symptoms of nausea, abdominal discomfort, vomiting and diarrhoea.

Harmful if swallowed. Ingestion of this product may cause irritation to the mouth, throat, oesophagus and stomach with symptoms of nausea, abdominal discomfort, vomiting and diarrhoea.

Inhalation

Harmful if inhaled. Inhalation of product vapours can cause irritation of the nose, throat and respiratory system. May cause irritation to the mucous membrane and upper airways, especially where vapours or mists are generated. Symptoms include sneezing, coughing, wheezing, shortness of breath, headache, dizziness, drowsiness, nausea and vomiting.

Skin

Harmful in contact with skin. Product can be absorbed through skin with resultant harmful systemic effects.

May cause an allergic skin reaction. Repeated exposure may cause skin dryness and cracking and may lead to dermatitis.

Eye

Causes eye damage. Eye contact will cause stinging, blurring, tearing, severe pain and possible burns, necrosis, permanent damage and blindness.

Reproductive Toxicity

Suspected of damaging fertility or the unborn child. Classified as a suspected human reproductive or developmental toxicant. Bromoxynil octanoate has been assigned Toxic to Reproduction Category 2 on the basis of studies, in rats, rabbits and mice which show reduced ossification and increased incidence of supernumerary ribs at doses (range 5-15 mg/kg/day) which are not toxic maternally.

STOT - Single Exposure

May cause drowsiness or dizziness.

STOT - Repeated Exposure

Not expected to cause toxicity to a specific target organ.

Aspiration Hazard

May be fatal if swallowed and enters airways.

Chronic Overexposure: Weight loss and damage to liver and kidneys may be expected if exposure is excessive.

Other Information

The Australian Acceptable Daily Intake (ADI) for bromoxynil for a human is 0.003 mg/kg/day, set for the public for daily, lifetimeexposure. This is based on the NOEL of 0.3 mg/kg/day, the level determined to show no effects during long term exposure for themost sensitive indicators and the most sensitive species.

ADI for MCPA is 0.01 mg/kg/day, NOEL 1.1 mg/kg/day. ADI for Dicamba is 0.03 mg/kg/day, NOEL 3 mg/kg/day.
